The Conference, under the conditions set out below, also includes a visit to the industrial plant of the company TŘINECKÉ ŽELEZÁRNY, a.s. in Třinec (hereinafter referred to as the “**plant**”).

4 Registration

Registration for the Conference starts on January 15, 2025. For registration will be activated the registration form through website of the Conference - www.steelsim2025.com/registration/. The registration form must be filled completely and sent to the organizer. Registration is not deemed to have been accepted by the organizer until a confirmation email has been sent to the participant.

It is not possible to register for the plant visit without previous registration for the Conference by the above stated procedure. The number of participants in plant visit is limited, the organizer reserves the right to refuse registration for the plant visit if the maximum number is reached.

5 Cancellation by organizer

The organizer is entitled to cancel the Conference at any time. If the Conference is cancelled by the organizer, all fees already paid to the organizer's account will be refunded. This does not apply to costs related to cancellations of accommodation and transportation, which will not be refunded.

6 Cancellation by participant

Cancellation by the participant:

- until 15.4.2025 is free of charge (100 % of the participation fee will be refunded).
- from 16.4.2025 to 15.6.2025 cancellation is charged by 60 % of the participation fee (60% will be forfeit, 40 % will be refunded), unless the participant is replaced, which might be subject to additional fee (replacement participant);



- from 16.6. 2025 cancellation is charged is charged by 100 % of the participation fee (100 % will forfeit), unless the participant is replaced, which might be subject to additional fee (replacement participant);
- Fee for a replacement participant: additional fee will be charged only if the registration is changed at the same time (for the registration subject to a higher fee).

7 Participation fee

The total amount of the participation fee is due on the date specified on the invoice. The participant agrees to the sending of an electronic invoice to the email address provided during registration. If payment is not made until the due date, the organizer reserves the right to cancel participants registration for the Conference with no refundation. Non-attendance does not however cancel the obligation to pay the participation fee and does not establish any right to demand its return or any other compensation or replacement.

If a participant registered as a "SPEAKER" does not deliver Paper for his Contribution by 20.06.2025, the organizer reserves the right to change registration of that participant to a "Regular participant", exclude his Contribution from the program and the Conference Proceedings, and demand payment of the difference in fee for the registration.

8 Dates & times

The exhibition rooms will be open each day for 30 minutes before the start of the event and for 30 minutes after the event. The registration desk will be open on September 1 from 5:00 PM to 8:00 PM at the STEELHOUSE Hotel and from 08:00 AM at the venue on the following days.

9 Accommodation

Accommodation is not provided or guaranteed by the organizer. The Conference website only lists recommended accommodations with distances from the conference venue.

10 Plant visit

The participant of the visit to the plant will be equipped with protective equipment - a coat, helmet, safety glasses and hearing protection, which will be provided or otherwise secured by the organizer. The participant is required to wear long trousers and full-length shoes. A safety briefing will be held before the visit to the plant.

The duration of the plant visit is approximately 2 hours including transport.

There are two options - the participant is obliged to choose one of them, while the organizer is entitled to change this choice:

- Steel production route (BOF, round bloom continuous caster)
- Long product rolling route

It is not possible to participate in both routes at the same time.

During the plant visit, participants are required to follow the instructions of the persons providing guidance during the visit.



11 Surveillance of the event venue

The organizer will not be providing any general surveillance of the event venue. However, participants must follow the instructions of the organizer at the venue, as well as the conditions and instructions set by TRISIA, a.s. (owner of the place of the venue), as well as persons authorized to act on behalf of TRISIA, a.s.

12 Disclaimer of liability or insurance

The participants waive any rights for any compensation of any damage, loss or other adverse effects, which occur in the course of the event. The same applies to any of their rights to compensation related to any fault on the part of third parties, e.g. vicarious agents of the organizer and so on. This waiver also applies to fault on the part of the organizer.

13 Changes

The organizer reserves the right to make adjustments to the event content, mainly to the program of the Conference, to use replacement speakers and also to reschedule times and change locations.

14 Image rights, poster, presentation and text material

The organizer will take photographs and camera recordings of the event and participants for documentation purposes. Upon registration, participants consent to the use of these images without restriction and in all media.

Authors agree to their submitted posters, presentation and text material being used by the organizer.

15 Personal data

16 VISA
